

Payment Plans

Student payment plans may be available:

- Where the student is over 18 years of age
- Where the student tuition fee is not being met by another party (employer)
- Where the total tuition fee is more than \$500 and less than \$10,000

Payment plans are available by application whereby the financial position of the student will be assessed individually. Evidence must be supplied to support the application. Terms and conditions apply.

Payments not met

Where payments are not met:

- The student will be suspended from course until payment arrangement obligations are met
- If the student fails to settle their debt in the agreed time, WG Learning Pty Ltd (known as TU NSW and TU QLD) will engage the services of a Debt Collection Agency to recover debt.

Process for monitoring

- Payment plan details will be entered into Student Management System
- Student accounts will be reviewed on the 15th day of each month
- Monthly statements sent to students on the last day of each month

Payments and Credit Policy

Refunds

WG Learning has adopted a policy for student refunds that is deemed to be fair and equitable to both the student and the RTO. This refund policy is advised in writing prior to student enrolment. The refund policy has been designed to enable students to seek a refund where they legitimately believe this is applicable.

The refund policy is as follows:

- Should WG Learning cancel a qualification/ course, students are entitled to a full refund or transfer of monies to a future qualification/ course.
- Documentary evidence detailing the reasons for a refund must be provided to WG Learning.

For funded training, refunds will be made in accordance with relevant State and Territory legislation; provision of a full refund will be given to a trainee for any student contribution fee charged for training delivered, where training has not commenced at the time of enrolment cancellation

WG Learning may require a deposit, which will not exceed \$1,500 per individual student, prior to course commencement. If the full course fees are below \$1,500, the full fees may be required prior to course commencement.

For Full Fee Paying Students

- All courses are subject to WG Learning's non-refundable \$10 enrolment fee.
- WG Learning will hold all credit until a period of two (2) months after original booking date. After this, course credit is expired and cannot be used or refunded.
- Student is unable to attend due to illness or other medical condition: must provide a medical certificate within two weeks of the training date, otherwise the standard cancellation policy and rescheduling fees apply. A medical certificate will not be accepted if a student is late or has insufficient ID.
- Refunds requests must be applied for in writing by the student so we can verify their identity and keep a record of the request. If your refund is approved, funds will be returned to you by the means in which it was paid. If the course fee was paid by a third party, the third party will be credited the course fee, unless stated otherwise.

Withdrawal

If students need to withdraw from training, they may be entitled to refund of any fees paid in advance for study not yet commenced. WG Learning will consider individual applications for fee waivers or refunds, in line with relevant State/Territory or Commonwealth funding guidelines where applicable, based on hardship and liaise with students directly to reach a solution.

Cancellation

Funded Students

If WG Learning cancels any part of training; students will not be liable for costs associated with that training. Students will be provided with a Statement of Attainment for all completed units of competency and offered the opportunity to re-enrol with us or another RTO with full recognition of that statement.

Full Fee Paying Students

- More than 24hr before the course start time = \$25 cancellation fee per course
- Less than 24hr before the course start time = \$50 Refund
- Late to course start time or Insufficient ID on the course date = \$50 Refund
- No Attendance or unable to pass course (e.g. doesn't return from break or is late back from break) = No Refund
- All cancellation fees refer to the original booking date (ie, rescheduled courses may not be eligible for refunds)
- In the event of an existing competency, the student can be provided a partial refund of the compliance fees.
- Course cancelled by WG Learning: participants have the option of rescheduling to another date or receive a full refund of the course fee paid. No further monies will be paid for any other expenses the participant has or may incur.

Additional Fees

There may be some additional costs to the student not included in tuition fees. These might include specialist equipment retained by the student after the training or optional charges for additional resources beyond or in a different format from what are provided as part of the course. Any additional costs will be explained prior to being charged.

There may be additional fees incurred for additional LLN services. All services will be discussed with students before they are required to make any commitment.

Fee's for RPL will be assessed on an individual basis. Credit Transfer will incur no fees.

Outstanding Fees

WG Learning will attempt to recover outstanding fees by contacting the student directly via contact details provided at enrolment (or updated throughout the training period). Where applicable, WG Learning will discuss payment plan options and personal circumstances. If payment is not received in full at completion of training, any testamurs (Certificates, Diplomas or Advanced Diplomas) or Statements of Attainment will be withheld until payment is received.

If payment is still outstanding six (6) months from the planned completion date or the date upon which the student was deemed competent in all units (which ever comes later), WG Learning will engage the services of a debt-collecting agency to recover outstanding fees.

Payments and Credit Policy

NSW Fee Policy

WG Learning will not charge more than the student contribution fees as stated in the current Smart and Skilled Policy, unless we are advised of any changes by the Department.

Where WG Learning collects a student contribution fee, it may be paid on behalf of the student by their employer or a third party unrelated to WG Learning but cannot be paid or waived by the WG Learning (whether directly or indirectly), unless approved in writing by the department.

Fee-Free Training

A student who falls into one of the following categories will qualify for fee free training:

- an Aboriginal or Torres Strait Islander person - An Aboriginal or Torres Strait Islander student can prove their status and eligibility for a fee exemption through descent, self-identification, and community identification
- a student with a disability, eligibility criteria:
 - is in receipt of the Commonwealth Government Disability Support Pension, or
 - supplies documentary evidence that is assessed by the provider and demonstrates a clear additional need as a result of the student's disability.
- a dependent child, spouse or partner of a recipient of a Disability Support Pension - A student who is a dependant of a person with disability will be eligible for a fee exemption based on this category. These students will need to provide documentary evidence to show they are a dependent child, spouse, or partner of someone who is receiving a Commonwealth Government Disability Support Pension.

A waiver must be applied to an eligible enrolment in order to access funding under this initiative

- a refugee or asylum seeker – for training up to and including Certificate IV - A refugee or asylum seeker (and their eligible partners) will be eligible for a fee exemption for Smart and Skilled training up to and including Certificate IV provided they hold or held one of the visas listed in Appendix 1: Refugees and asylum seekers of the Smart and Skilled Student Eligibility Policy.

These students will need to provide evidence of their visa documentation, or documentation such as an ImmiCard where appropriate.

A waiver must be applied to an eligible enrolment in order to access funding under this initiative

- a recipient of a Fee-free Scholarship – for training up to and including Certificate IV who meet the criteria set out further below

Payments and Credit Policy

Queensland Fee Policy

WG Learning will not charge more than the student contribution fees as stated in the current SAS Policy, unless we are advised of any changes by the Department.

Where WG Learning collects a student contribution fee, it may be paid on behalf of the student by their employer or a third party unrelated to WG Learning but cannot be paid or waived by the WG Learning (whether directly or indirectly), unless approved in writing by the department.

Partial Exemption of Tuition Fees in Queensland

WG Learning will charge 40% of the student contribution fee where the student falls into one or more of the following exemption categories:

The student was or will be under 17 years of age at the end of February in the year in which WG Learning provides training, and the participant is not at school and has not completed year 12.

- The student holds a Health Care Card or Pensioner Concession Card issued under Commonwealth law or is the partner or a dependent of a person who holds a Health Care Card or Pensioner Concession Card and is named on the card.
- The student issues WG Learning with an official form under Commonwealth law confirming that the student, his or her partner or the person of whom the student is a dependent, is entitled to concessions under a Health Care Card or Pensioner Concession Card.
- The student is an Aboriginal or Torres Strait Islander person. Acceptable evidence is as stated on the Training Contract and AVETMISS VET Enrolment Form.

Full Exemption of Tuition Fees in Queensland

WG Learning may apply full exemption from the student contribution fee where the student falls into one or more of the following exemption categories:

- Where payment of the student contribution fee would cause extreme financial hardship, then the PQS may waive these fees:
- Undertaking a Qualification as part of the Skilling Queenslanders for Work or SQW – Work Skills Traineeship program;
- School-based apprenticeship or traineeship;

Payments and Credit Policy

- Specific fee-free training programs as announced by the Queensland Government;
- Foundation skills – this training is fee-free.

Fee-Free Year 12 Graduates in Queensland

The SAS must not charge a fee to any individual who is eligible for a Government subsidy under the Free Apprenticeships for Under 25s initiative. The Department will cover the Co-contribution fee
